About the Program

Are you a senior manager, consultant or entrepreneur who wants to draw together both the theoretical and practical aspects of leadership and managerial experience? Designed to enable you to develop professional practice, theoretical understanding and reflexive capability, the DBA is a high level, innovative qualification and an alternative route if you wish to research your professional practice at doctorate level.

The DBA program is designed for working professionals who have the motivation to expand their knowledge/skills and get a doctorate degree without interrupting their work. It is a collaboration between Plymouth University and the International Institute in Geneva. The first four modules will be taught over four weekends at the International Institute in Geneva (IIG). The DBA degree is awarded by Plymouth University.

The program starts in October of each year.

Why DBA?

The DBA is a part time *professional doctorate* and it aims to support the development of professional practice. It is also a research degree, equivalent to the more traditional PhD, and therefore this development is designed to take place through a process of research methodological training leading to clearer theorisation of practice, structured first by modules and then by your thesis. Being at D-level (doctoral level) means that this should result in new knowledge and understanding that makes an original contribution to your field.

The Program has two phases

Year 1 - Taught phase

You will attend three 3-day (Friday-Saturday-Sunday) workshops organized in around every 3 months at IIG:

1- Advanced Qualitative Research Methods for Doctoral Study 2- Advanced Quantitative Research Methods for Doctoral Study 3- Applying Theory to Professional Practice

Year 2 - Research proposal preparation&validation phase

There will be workshops and seminars to help you to develop a Research Proposal under the supervision of a research advisor.

Year 3&4 (can be extended to 5)- Thesis/Research phase)

Progression into the thesis/research stage is dependent on successfully passing all of the modules in years 1 and 2 of the program. This then allows you to commence the thesis/research stage (year 3).

The thesis stage requires you to undertake a substantial piece of original research into an area of practice of your own choosing through which you make an original contribution to knowledge. The research is presented as a thesis of approximately 45,000 words which is assessed through a viva voce examination.
